

**2008 Ultimate Tennis Experience Raffle Contest
OFFICIAL RULES AND REGULATIONS**

1. **ELIGIBILITY.** **The Ultimate Tennis Experience Raffle Contest** (“Contest”) is open to legal residents of the state of Georgia, who are at least 18 years of age as of the date and time the Contest is first made known to the public. By entering the Contest, participants agree to accept and be bound by all terms of these Official Rules and Regulations. Contest is subject to all federal, state and local laws and regulations. Some restrictions apply. Void wherever prohibited or restricted by law.

Sponsor is not responsible for misdirected, incomplete, lost, late or illegible entries, technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems which may limit a participant’s ability to participate in the Contest or damage to a user’s system as a result of participation in the Contest or downloading of any information necessary to participate in the Contest. False or deceptive entries or acts, as determined by Sponsor, will render the entrant ineligible. Sponsor reserve the right, in their sole discretion, to cancel or modify the Contest should any computer virus, malfunction or other cause beyond their control corrupt the administration, security or proper operation of the Contest. All entries become the property of Sponsor and will not be returned. All entries must be submitted in the name of an individual person and the prize can only be awarded to the person whose name is on or corresponds to each winning entry.
4. **HOW TO WIN.** One (1) winner will be selected on April 8, 2008 by random drawing conducted by a representative from the Sponsor. The first entry selected will be deemed the winner. The odds of becoming a winner will be determined by the number of eligible entries received. The winner will be notified by telephone or email, and must meet all eligibility requirements including the execution and delivery of all necessary releases. Contest will be administered by the Sponsor, the decisions of which in all matters regarding the Contest are final and binding.

Failure to do so, or if any prize or prize notification is returned as undeliverable, or if a winner fails to respond to notification attempts, or is not in compliance with these rules or is determined to be ineligible for whatever reason, such winner will be disqualified and an alternate winner may be selected by random drawing from among all remaining eligible entries received from the disqualified or winners’ method of entry, at the Sponsor’s sole discretion. If no eligible winner can be identified after reasonable attempts or if delays in obtaining the completed Winner Documents would make it impracticable to select an alternate winner due to the timing of the February 18, 2008 Prize Event or any other reason determined by the sponsor, no substitute winner will be selected. In the event more winner notifications are issued, or more winning prize claims are received, than the number of prizes set forth in these Official Rules due to computer, printing, seeding, human, or other error or problem, a random drawing will take place from all eligible prize claims for the prize at issue to award the proper number of prizes as set forth in these Official Rules. These Official Rules constitute an Agreement. If any term or provision of this Agreement or the application thereof to any persons or circumstances shall, to any extent, be invalid or unenforceable, the remainder of this Agreement or the application of such term or provision to persons or circumstances other than those as to which it is held invalid or unenforceable shall not be affected thereby, and each term and provision of this Agreement shall be valid and enforceable to the fullest extent permitted by law.

In the event of sabotage, acts of God, computer virus or other events or causes beyond the Sponsors’ reasonable control, which corrupt the integrity, administration, security or proper operation of the Contest, the Sponsor reserves the right to cancel or suspend the Contest. If any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
